#### Pradnyawati



Ms. Pradnyawati has been the Director of the Directorate of Trade Defence of the Directorate General of Foreign Trade (DGFT) of the Ministry of Trade of the Government of Indonesia since May 2016. She is now leading the team of trade specialists to defend trade remedy cases for Indonesia in collaboration with the private sector companies in Indonesia. Prior to this position, Ms. Pradnyawati was the Secretary to DGFT from November 2015 to May 2016 and the Director in charge of development of promotion and branding at the DGNEP from February 2012 to November 2015. She was also the Director of Bilateral Cooperation of DGITC, responsible for bilateral trade negotiations for Indonesia from September 2010 to January 2012.

Ms. Pradnyawati obtained her Master's Degree in Political Science from the McMaster University, Hamilton, Canada.

#### Peter Clark



Mr. Peter Clark is the President of Grey, Clark, Shih and Associates, Limited. After graduating from St. Patrick's College of the University of Ottawa, Mr. Clark joined the Government of Canada, in 1965, where he worked primarily in the Department of Finance on a wide range of trade policy issues. He was seconded to the Department of External Affairs as Counselor at the Canadian Permanent Mission to the United Nations (Geneva) where he was Canadian Liaison to the GATT, Chairman of the GATT Standing Committee on Budget, Finance and Administration and a founding member of the Textile Surveillance Body.

Mr. Clark is one of Canada's most active international trade practitioners. His clients include governments, corporations and trade associations in Canada and around the world. He is active in North American Free Trade Agreement (NAFTA) and World Trade Organization (WTO) dispute settlement both as Counsel and as an Arbitrator. Through CIDA, EU, UNDP and UNCTAD project activities, he has been an advisor to many developing countries on how to adapt to and implement international trade rules and to cope with trade actions against their exports.

Mr. Clark is a frequent media commentator and appears regularly before the Parliamentary Committees, analyzing trade and commercial policy issues. His government relation expertise has received public recognition in various publications including the The Hill Times, "Top 100 Lobbyists List", and "Top 50 Consultant Lobbyists List."

## Erry Bundjamin



Mr. Erry Bundjamin is the founding Partner of Bundjamin & Partners Law Offices in Jakarta. In 1999, Erry Bundjamin established Bundjamin & Partners, which has become the premier Indonesian law firm in the area of international trade law, customs law, competition law, and litigation practices. Mr. Bundjamin has been recognized by prominent publications such as Chamber & Partners (since 2009) and Who's Who (since 2006) as Indonesia's leading lawyer in areas of trade remedies. He is also recognized for his practice in competition law.

Mr. Bundjamin has represented numerous Indonesian producers in trade remedies cases. He has assisted the Government of Indonesia in anti-subsidy investigations. For example, at the WTO, Mr. Bundjamin represents the Government of Indonesia in its dispute against the EU on the imposition of anti-dumping duty on biodiesel as well as the U.S. anti-subsidy investigation on biodiesel. Mr. Bundjamin has also represented foreign producers of various industries including steel and chemical products in anti-dumping and safeguard investigations.

Mr. Bundjamin has written various articles published on the implementation of trade remedies law in Indonesia. For example, "Indonesia: A Judicial Review System in Dire Need of Restructuring" was published in Cambridge in 2013, "Judicial Review of Anti-dumping Determinations in Indonesia" was published in 2012 in the Global Trade and Customs Journal, and "International Dumping and Injury Margin Calculation Methods: Ten Major Problems in Indonesian Practice" was published in Global Trade and Customs Journal in 2007.

In addition, he serves as lecturer at prominent universities in Indonesian, some in collaboration with the Ministry of Trade of Indonesia, such as the University of Indonesia, the University of Padjajaran, and the University Gajah Mada. Mr. Bundjamin is a licensed advocate in Indonesia under the Indonesian Bar Association (PERADI).

## Wenguo Cai



Wenguo Cai is currently the Director of International Programs of the Conference Board of Canada, responsible for business development and trade-related technical assistance in developing countries and transition economies. He has almost 30 years of trade-related work experience. He used to be a trade negotiator in the Ministry of Foreign Trade and Economic Cooperation (now the Ministry of Commerce) of the Government of China and travelled to Geneva for many trade negotiations in the 1980's. After he moved to Canada in 1988, he worked at the Centre for Trade Policy and Law (CTPL) in Ottawa from 1991 to 2003, primarily responsible for the design, delivery and management of trade-related technical assistance projects in Asia and other developing countries.

He joined the Conference Board of Canada (CBoC) in December 2003, and since then, he has been working on trade policy analysis and trade-related capacity building in many developing countries. In the last 25 years, he has designed, delivered, managed and evaluated more than 100 trade-related projects in Asia, Africa, Latin America, Europe and the Pacific. He has lectured frequently on WTO and other trade issues, and published many articles on trade and development in academic journals, including the *Journal of World Trade*, and *World Competition: Law and Economic Review* in Geneva. Several of his publications are translated into Vietnamese, Chinese, Urdu and Russian.

He has served as a consultant to the GAC (CIDA), EU, UNDP, UNCTAD, ESCAP, ASEAN, PIFS, DFID, the World Bank and some private companies and NGOs. He has participated most of the WTO Ministerial Conferences from Singapore to Nairobi. He holds an M.A. in Public Administration from Carleton University, Ottawa, Canada and an M.A. in Economics from Nankai University, Tianjin, China.

## Alexandre Larouche-Maltais



Alexandre Larouche-Maltais is Senior Trade & Investment Expert within International Programs of The Conference Board of Canada, primarily responsible for providing technical assistance under the Canada-Ukraine Trade and Investment Support (CUTIS) and Canada-Indonesia Trade and Private Sector Assistance (TPSA) Projects. In addition to taking part into policy and regulatory dialogues and study tours, he also provides training on trade and investment to governmental officials and private sector representatives for raising their awareness on cross-border trade topics and building their trade capacities. Under the CUTIS and TPSA Projects, Alexandre also conducts research on selected topics to increase trade and investment between Canada and the two target countries.
